3. SUBMISSION OF BIDS

- 3a. Bids may be submitted starting August 28, 2013 from 9:00 a.m. until 4:00 p.m. c/o the Administrative Department, Tourism Promotions Board with office address at 4th Floor Legaspi Towers 300 Roxas Blvd., Manila. Deadline for submission will be at 12:00 noon of August 30, 2013.
- 3b. Bids will be opened on August 30, 2013 at 2:00 p.m., at the Administrative Department, TPB. The participating bidder or his/her duly authorized representative is enjoined to witness the opening of the sealed bids.

4. WINNING BIDDER

- 4a. The winning bidder shall post a deposit of 10 % of his/her bid amount right after the opening of bid.
- 4b. Deposit of the winning bidder shall remain with the Bidding Committee until such time that the winning bidder completely removed the bidding item.

5. PAYMENT AND REMOVAL OF PROPERTY

- 5a. Full payment must be made on or September 3, 2013 between 9:00 a.m. to 4:00 p.m. In the event that the winning bidder fails to complete the payment within the specified period. TPB shall have the right to award the properties to the next highest bidder without prejudice to the confiscation of the deposit.
- 5b. The winning bidder shall remove the awarded properties only after the check payment has been cleared with the bank. In which case, a clearance effecting the removal of the items shall be issued by TPB.
- 5c. The winning bidder shall remove the properties within seventy-two (72) hours after the clearance has been issued. Otherwise, TPB shall charge a storage fee of ten percent (10%) of the bid price per day of delay in removing the items.
