II. BACKGROUND

For 2017's second segment, 21 of TPB's personnel volunteered to join in the CSR Las Piñas-Laguna leg. Additionally, two bloggers accepted TPB's invite to join the group and cover the activities. Partnering with Haribon Foundation, participants took part in a Las Piñas Parañaque Protected Critical Habitat and Ecotourism Area (LPPCHEA) coastal clean-up initiative and in the planting of 500 Philippine native seedlings at the Caliraya Lake Lumot Watershed.

NOTE: Due to heavy rains making the ground slick and hard to traverse, the Forester serving as guide for the tree planting activity advised the team to leave Villa Escudero earlier. However, given the weather condition, the group was unable to leave earlier as planned. The arrival back to Legaspi Towers 300 from the CSR activity was also later than expected due to heavy traffic.

IV. HIGHLIGHTS OF CSR LAS PIÑAS-LAGUNA

For this particular leg of the CSR Program, the participants were able to engage in activities giving importance to:

1. Environmental sustainability

Coastal Clean Up at LPPCHEA

The TPB employees underwent a general briefing about the present situation of LPPCHEA and why it was critical to conduct clean ups within the area. Following the orientation, TPB employees grouped themselves then agreed on designated trash to be collected. Each group's leader recorded the number of sacks of trash collected.

All together, TPB employees with guests collected thirty eight (38) sacks in total. Mr. Joseph Senga of Haribon Foundation shared that it was a good number considering the time programmed/allotted by Haribon Foundation to the group.

Tree Planting at Caliraya Lake Lumot Watershed

Haribon Foundation strongly advocates the restoration of Philippine forests. They support (in partnership) tree planting activities in several locations.

Mr. Thaddy, forester representative of Haribon briefed TPB employees before the planting activity. The group then proceeded to the assigned location via partial boat ride and partial hike. Other Haribon volunteers joined with TPB employees to form five "planter" groups with five individuals each group. The tree planting activity started immediately after a tree planting demonstration by the forester.

TPB employees persevered to plant 500 native seedlings in adverse weather with rain and slippery slopes. A further 750 seedling is scheduled to be planted by TPB volunteer employees in July of 2018.

As the lead agency which markets the Philippines as a tourism destination, a "product update" was part of the program. The group was able to visit the following places, having fun in their engagement activities:

Villa Escudero Tour

TPB personnel went to Villa Escudero which functioned as the official hotel accommodation of the group. Welcome drinks were provided upon arrival followed by a short break. Then, the carabao kart was available to transfer TPB employees and guests to the Labasin waterfall restaurant for lunch. Post lunch, the group proceeded to the museum for a historical and spiritual brief by the assigned guide. After, TPB employees went to their rooms for check in and the remaining time was given for leisure.

- Assistance from Mr. Joseph Senga of Haribon Foundation as official partner and coordinator for the CSR activities in Las Piñas and Laguna
 - Orientation before the conduct of the coastal clean up

 Endorsement to Forester who provided orientation and assistance to the group before the tree planting activity

- Environmental and cultural awareness among participants of the CSR activity helps to develop individual appreciation for the importance of green tourism which they can share or impart to their respective circle of friends and families;
- Networking and building/strengthening relationships with the local communities, LGU, tourism stakeholders and even among TPB employees as possible and potential partners for future TPB CSR and non-CSR projects;
- Additional first-hand knowledge of the country's tourism products and services that will hopefully help them become more productive personnel of the Corporation;
- Articles to be published through the assistance of MARCOM (including online postings on TPB social media accounts) and the invited bloggers.
- Documentary stories to feature on TPB website and other social media accounts.
