

### **TERMS OF REFERENCE**

PROJECT: SUPPLY, PRODUCTION AND DELIVERY OF 2019 TPB OFFICE UNIFORMS

#### I. BRIEF DESCRIPTION:

This procurement refers to the supply, production and delivery of office uniforms for forty-nine (49) female employees and twenty-six (26) male employees of the Tourism Promotions Board.

### II. APPROVED BUDGET FOR THE CONTRACT (ABC):

**LOT 1 = TWO HUNDRED NINETY FOUR THOUSAND (Php294,000.00)** inclusive of all applicable taxes

LOT 2 = ONE HUNDRED FIFTY SIX THOUSAND (Php156,000.00) inclusive of all applicable taxes

#### IV. CRITERIA FOR SELECTION

The proposal shall be evaluated using the Quality Cost-Based method, where 50% shall be allocated for Cost and 50% for Quality as follows:

The quality of submitted samples shall be evaluated on the following;

- 1. Work: includes workmanship, design and durability
- 2. Fabric: includes comfort, fit and appeal

**Note:** Bidders should submit the following:

- 1. Sample sets of the above requirements
- 2. Swatches for proposed color combinations and thread color for embroidery
- 3. Suggested embroidery patterns

#### V. ELIGIBILITY REQUIREMENTS

- 1. Must be operated and legally registered supplier under Philippine laws;
- 2. Must be accredited with the Philippine Government Electronic Procurement System (PHILGEPS)
- 3. Must submit the following legal documents to be eligible to participate:
  - SEC/DTI Registration Certificate
  - Mayor's Permit/License
  - BIR Registration/TIN
  - Company Profile/Reference

### VI. Contract of Service

The proposal should cover the following requirements/arrangements:

- 1. Must ensure that approved fabrics are available in time for production of uniforms
- 2. Must ensure that alteration services are made available, as may be required
- 3. Meet-ups must be done in the TPB Office
- 4. Should the project be awarded to two (2) suppliers, TPB reserves the option to adjust in the color scheme and details of the design of the uniform
