I. BACKGROUND

The Pediatric Infectious Disease Society of the Philippines, Inc. (PIDSP) will be hosting its 11th World Congress of the World Society for Pediatric Infectious Diseases on 05-08 November 2019. The Congress expects the participation of 800 foreign and 700 local delegates.

TPB's assistance to the event will include the provision of a cultural entertainment during the Opening Ceremony and Welcome Reception 05 November 2019 in PICC.
