

**INVITATION TO BID FOR THE PRODUCTION, SUPPLY, AND  
DELIVERY OF TEN (10) THOUSAND PIECES CORPORATE TOTE  
BAG WITH SEVEN (7) DIFFERENCE WEAVE CLOTH DESIGN  
(ITB No. 2020-07)**

1. The *Tourism Promotions Board (TPB)*, through the *Corporate Operating Budget and Work Program for C.Y. 2020* intends to apply the sum of **FOUR MILLION TWO HUNDRED THOUSAND PESOS ONLY (Php 4,200,000.00)**, inclusive of all applicable vat, being the Approved Budget for the Contract (ABC) to payments under the contract for the **Production, Supply, and Delivery of Ten (10) Thousand Pieces Corporate Tote Bag with Seven (7) difference Weave Cloth Design**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **TPB** now invites bids for the **Production, Supply, and Delivery of Ten (10) Thousand Pieces Corporate Tote Bag with Seven (7) difference Weave Cloth Design**. Delivery of the Goods is required on *30 Calendar days upon receipt of Notice to Proceed and approval of complete set of actual bag samples*.

Bidders should have completed, within **three (3) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from **TPB** and inspect the Bidding Documents at the address given below during **9:30 am – 6:30 pm**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **25 February – 17 March 2020** from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of FIVE THOUSAND PESOS ONLY (Php 5,000.00)*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity,



provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **TPB** will hold a Pre-Bid Conference on **05 March 2020, 2:00 p.m.** at **TPB Office, 4<sup>th</sup> Floor Legaspi Towers 300 Roxas Blvd., Malate, Manila**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **17 March 2020, 2:00 p.m.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause.

Bid opening shall be on **17 March 2020, 2:30 p.m.** at **TPB Office, 4<sup>th</sup> Floor Legaspi Towers 300 Roxas Blvd., Malate, Manila**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. **Submit two (2) actual samples of bag using Ikat and Hinablon weave cloth/tribal accent and actual swatches of recommended patterns, at least two (2) swatches per kind. Failure to submit/present will not be considered and will be disqualified.**
9. The **TPB** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its RIRR, without thereby incurring any liability to the affected bidder or bidders.
