

**BAC RESOLUTION DECLARING TANJER ENTERPRISES
AS A BIDDER WITH A SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND
RECOMMENDING AWARD OF CONTRACT FOR THE PRODUCTION AND DELIVERY OF
MARKETING COLLATERALS**

RESOLUTION NO. 2019 – 459

WHEREAS, the TPB, through its Bids and Awards Committee (BAC), posted the Invitation to Bid No. 2019-25 for the Production and Delivery of Marketing Collaterals with a total Approved Budget for the Contract (ABC) of **TWO MILLION ONE HUNDRED THOUSAND PESOS ONLY (Php2,100,000.00)**, broken down to (5) Lots [Lot 1: Carry-On Luggage (Php937,500.00); Lot 2: Collared Shirts (Php300,000.00); Lot 3: Reversible Corporate Jacket (Php600,000.00); Lot 4: Luggage Tag (Php122,500.00); Lot 5: Passport Sleeves (Php140,000.00)] in the TPB website (www.tpb.gov.ph), the PhilGEPS and a conspicuous place at the premises (TPB Bulletin Board) for twenty-one (21) days;

WHEREAS, on 22 November 2019, the BAC held the pre-bid conference which was attended by the prospective bidders namely: GT Prime, IPower Product, Cristanelle, Christian Stephen Garments, 8 Times 8 General Merchandise, 347 S.O.S.I, and Tanger Enterprises.

WHEREAS, the BAC, through its BAC Secretariat issued a Supplemental Bid Bulletin No. 2019-051 dated 25 November 2019 posted in PhilGEPS, and TBP website for the purposes of modifications and/or clarification made during the pre-bid conference;

WHEREAS, for Lots 1-5 two (2) prospective bidders purchased the bidding documents, namely: GT Prime Management and Tanger Enterprises but only one (1) bidder, Tanger Enterprises, submitted their bids before the 10:00 a.m. deadline on 05 December 2019.

WHEREAS, during the said opening of bids, the BAC Chairperson, Ms. Janet W. Canoy, announced the postponement of opening of the bid due to lack of quorum of BAC member and the lone bidder shall be advised of the new date.

WHEREAS, on 09 December 2019 was schedule the new date of bid opening, during the opening of bid, the BAC Committee and its member examined Legal Documents submitted by the lone bidder, Tanger Enterprises, using non-discretionary "pass/fail" criteria;

The lone bidder, Tanger Enterprises, submission of eligibility requirement has been found to be eligible and its Technical Specifications has been found to be compliant.


