

CONTRACT AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This agreement is made and entered into the City of Manila, Philippines, this FEB 05 2020 day of _____, 2020 between:

TOURISM PROMOTIONS BOARD, a Government Owned and Controlled Corporation, with principal address at 4th Floor, Legaspi Towers 300, Roxas Boulevard, Manila, Philippines, herein represented by its Officer-in-Charge, Chief Operating Officer and Alternate Chairperson, **USEC. BENITO C. BENGZON, JR.**, hereinafter called the "**ENTITY**";

-and-

MARY ANN S. TAN/TANJER ENTERPRISES, a sole proprietorship duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with business address at 1104 Tower B Antel Seaview Towers Condominium, Pasay City, herein represented by its Authorized Representative, **ANGELICA S. TAN¹**, hereinafter called the "**SUPPLIER**".

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., **PRODUCTION AND DELIVERY OF MARKETING COLLATERALS**, which shall be delivered within thirty (30) calendar days after the approval of final proofing, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION EIGHT HUNDRED EIGHTY EIGHT THOUSAND AND TWO HUNDRED PESOS ONLY (PHP 1,888,200.00)**, hereinafter called the "Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
 - a. Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation (Annex "B");
 - b. General and Special Conditions of Contract (Annex "C");
 - c. Schedule of Requirements (Annex "D");
 - d. Technical Specifications (Annex "E");
 - e. Performance Security (Annex "F");
 - f. Entity's Notice of Award of Contract and the Bidder's conforme thereto (Annex "G");
 - g. Instructions to Bidders (Annex "H");
 - h. Eligibility requirements, documents and/or statements (Annex "I");
 - i. Addenda and/or Supplemental/Bid Bulletins (Annex "J"); and
 - j. Other contract documents that may be required by existing laws and/or Entity.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
5. This Contract Agreement shall take effect upon receipt of the Notice to Proceed.






