 The Tourism Promotions Board (TPB), through the 2021 Approved Corporate Operating Budget, intends to apply the sum of Two Million Five Hundred Thousand Pesos Only (Php2,500,000.00), inclusive of all applicable taxes, being the Approved Budget for the Contract (ABC) to payments under the contract for SERVICE PROVIDER FOR THE CONDUCT OF TOURISM MARKETING EDUCATIONAL SEMINAR 2021 / TO DESIGN AND IMPLEMENT AN ONLINE TOURISM MARKETING EDUCATIONAL SEMINAR (WEB CONFERENCE / WEBINAR). Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposal.

Instructions for submission of Eligibility Documents:

Bidders are instructed to submit in electronic bid submission, to ensure the security, integrity, and confidentiality of the bids submitted the bidders must submit their bid in **two (2) password-protected** compressed archive folder, one each for "Legal Component Documents" and "Technical Component Documents". The password for "Legal Component Documents" must be **different** to the password for "Technical Component Documents".

1<sup>st</sup> Sub-Folder "Legal Component Document" – must be password-protected. 2<sup>nd</sup> Sub-Folder "Technical Component Document" – must be password-protected (different password).









The passwords for accessing the files will be disclosed by the Bidders only during the actual eligibility opening which may be done face-to-face in person or through videoconferencing, webcasting or similar technology.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the TPB, provided that Bidders shall pay the applicable fee for the Bidding Document not later that the submission of their bids.

5. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provision of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Act", and its Implementing Rules and Regulations (IRR). The short list shall consist of five (5) prospective bidders who will be entitled to submit bids.

6. Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the IRR of RA 9184.







Bidding is restricted to Filipino citizen/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

- 7. The **TPB** shall evaluate bid using the **Quality-Cost Based Evaluation/Selection** (**QCBE/QCBS**) procedure. The Procuring Entity shall indicate the weights to be allocated for the Technical and Financial Proposals. The criteria and rating system for the evaluation on bids shall be provided in the Instructions to Bidders.
- 8. The contract shall be completed within five (5) months and/or from the date of acceptance of the Notice to Proceed until the presentation of the final report and all deliverable to TPB.
