DECLARING RBHC COURIER SERVICE AS A LOWEST CALCULATED RESPONSIVE BID (LCRB) AND TO AWARD THE CONTRACT FOR PACKAGING AND SHIPMENT OF BUCKET LIST COFFEE TABLE BOOK VERSION 1 & 2 TO PHILIPPINE DEPARTMENT OF TOURISM FOREIGN OFFICES

WHEREAS, there is an approved Purchase Request (PR) **No. 8.019** with an approved Budget for the Contract (ABC) of **One Million Four Hundred Thousand Pesos (PhP 1,400,000.00)**, for **Packaging and Shipment of Bucket List Coffee Table Book version 1 & 2 to Philippine Department of Tourism Foreign offices;**

WHEREAS, said item is included in the Annual Procurement Plan/Updated Project Procurement Management Plan of the Tourism Promotions Board (TPB) for 2021

WHEREAS, the TPB, through its Bids and Awards Committee (BAC), posted the Invitation to Bid No. TPB-ITB No. 2021-013 for the **Packaging and Shipment of Bucket List Coffee Table Book version 1 & 2 to Philippine Department of Tourism Foreign Offices** with a total Approved Budget for the Contract (ABC) of **One Million Four Hundred Thousand Pesos Only (PhP1,400,000.00)** in the TPB website (www.tpb.gov.ph), the PhilGEPS and conspicuous place at the premises of TPB Bulletin Board for twenty-one (21) days;

WHEREAS, on September 3, 2021, the Bids and Awards Committee (BAC) held the pre-bid conference which was attended by the following prospective bidders:

WHEREAS, the BAC, through its BAC Secretariat issued a Supplemental Bid Bulletin No. 2021-072 dated September 2, 2021 and Bid Bulletin No. 2021-073 date September 9, 2021 and posted in PhilGEPS, and TBP website for the purposes of modifications and/or clarification made during the pre-bid conference;

WHEREAS, on September 14, 2021, 2GO Express Inc. submitted their bids proposal;

WHEREAS, on September 15, 2021, RBHC Courier Services and All Transport Network, Inc. submitted their bids proposal before the set deadline of submission;

WHEREAS, on September 15, 2021, during the opening of the bid for the Packaging and Shipment of Bucket List Coffee Table Book version 1 & 2 to the Philippine Department of Tourism Foreign Offices the BAC Members, Project Officer, and the Technical Working Group (TWG) examined the bid proposal submitted by suppliers using non-discretionary “pass/fail” criteria.

WHEREAS, the BAC Members declared the bids of 2GO Express Inc., RBHC Courier Service and All Transport Network, Inc. as **Compliant and Eligible**.

WHEREAS, the BAC proceeded to open the financial proposal submitted by 2GO Express Inc., RBHC Courier Service, and All Transport Network, Inc. and as read as follows:

NOW THEREFORE, for and in consideration of the foregoing, we, the member of the Bids and Awards Committee hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

- a) to **DECLARE** RBHC Courier Service bid for Packaging and Shipment of Bucket List Coffee Table Book version 1 and 2 to the Philippine Department of Tourism Foreign Offices as a **Lowest Calculated Responsive Bid (LCRB)**;
- b) to **RECOMMEND** for approval of the Chief Operating Officer of the TPB to **AWARD** the Contract to **RBHC Courier Service** for **Packaging and Shipment of Bucket List Coffee Table Book version 1 and 2 to the Philippine Department of Tourism Foreign Offices** in the amount of **One Million One Hundred Ninety Six Thousand Two Hundred Fifty Pesos Only (Php1,196,250.00)** inclusive of all applicable taxes.


