

**INVITATION TO BID (ITB)  
NO. 2021-006**

**ONE (1) YEAR SUBSCRIPTION TO A TOURISM MARKET  
RESEARCH DATABASE**

1. The **Tourism Promotions Board** through the **2021 Approved Corporate Operating Budget** intends to apply the sum of **Four Million Five Hundred Thousand Pesos Only (PHP4,500,000.00)** being the ABC to payments under the contract for ITB No. 2021-006: One (1) Year Subscription to a Tourism Market Research Database. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Tourism Promotions Board** now invites bids for the above Procurement Project. Delivery of the Goods is required from receipt of the **Notice to Proceed but not earlier than 05 November 2021**. Bidders should have completed, **within five (5) years (for Market Research Service Provider) and three (3) years (for Reseller/Distributor)** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary *“pass/fail”* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

**Only (Php5,000.00).** The Procuring Entity shall allow the bidder to present its proof of payment for the fees **through electronic means.**

7. The **Tourism Promotions Board** will hold a **Pre-Bid Conference** on **08 July 2021 at 11:00am** through video conferencing or webcasting *via the Zoom virtual platform*, which shall be open to prospective bidders.
8. Bids must be duly received by the BAC Secretariat through online or electronic submission as indicated below, on or before **21 July 2021 at 1:30pm**. Late bids shall not be accepted.

The **Technical and Financial Documents** must be submitted separately in a compressed archive folder, the link/compressed folders shall be sent by email to the **[bac\\_sec@tpb.gov.ph](mailto:bac_sec@tpb.gov.ph)** on or before **21 July 2021 at 1:30pm**.

The **folders must be password-protected**, passwords will only be sent to the above-mentioned email address only upon the request of the presiding BAC representative during the bid opening.

9. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
10. Bid opening shall be on **21 July 2021 at 2:00pm** via the **Zoom** virtual platform. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The address for the opening of bids is via **Zoom** virtual platform, the link will be provided to prospective bidders who submitted the bid on or before **21 July 2021 at 1:30pm**.

E-mail the BAC secretariat of the name and email address of your representatives once the bid submission is duly acknowledged. As much as practicable a maximum of four (4) representatives per company is recommended.

The **Tourism Promotions Board** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
