

CONTRACT AGREEMENT

28 SEP 2021

THIS AGREEMENT made the _____ day of _____ 2021 between the **TOURISM PROMOTIONS BOARD**, a government owned and controlled corporation, with principal address at 4th Floor, Legaspi Towers 300, Roxas Boulevard, Manila, Philippines, herein represented by its Chief Operating Officer, **MARIA ANTHONETTE C. VELASCO-ALLONES**, hereinafter called the "ENTITY" of the one part; and **TOYOTA PASONG TAMO, INC.**, a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with business address at 2292 Pasong Tamo Extension, Makati City, Philippines, herein represented by its Authorized and Designated Representative, **AGNES ESCANDOR-RUBIS**, hereinafter called the "SUPPLIER" of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the procurement of "TPB MOTOR VEHICLES: SEDAN 4 DOORS (LOT 1) AND 3 VANS (LOT 2)", and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION FORTY THOUSAND TWO HUNDRED PESOS ONLY (PHP 1,040,200.00) AND FIVE MILLION SIX HUNDRED NINETEEN THOUSAND SIX HUNDRED PESOS ONLY (PHP 5,619,600.00)**, respectively, inclusive of all applicable taxes hereinafter called the "Contract Price";

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - iii. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iv. Performance Security;
 - v. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - vi. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, shall likewise form part of the Contract.**
3. In consideration for the sum of **ONE MILLION FORTY THOUSAND TWO HUNDRED PESOS ONLY (PHP 1,040,200.00) AND FIVE MILLION SIX HUNDRED NINETEEN THOUSAND SIX HUNDRED PESOS ONLY (PHP 5,619,600.00)**, inclusive of all applicable taxes, or such other sums as may be ascertained, the **SUPPLIER** agrees to deliver the **TPB MOTOR VEHICLES: SEDAN 4 DOORS (LOT 1) AND 3 VANS (LOT 2)**, respectively, in accordance with its Bid.
4. The **ENTITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
