**RECOMMENDING AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT  
TO MARCLYN MERCHANDISING FOR THE SUPPLY AND DELIVERY OF 17 SACKS OF  
RICE FOR SEPTEMBER 2021 TPB EMPLOYEES RICE ALLOWANCE**

**WHEREAS**, there is an approved Purchase Request (PR) No. 8.024 with an Approved Budget for the Contract (ABC) of **Forty-five Thousand Nine Hundred Pesos Only (PhP45,900.00)**, for the procurement of 17 sacks of rice for September 2021 TPB employees rice allowance;

**WHEREAS**, said item is included in the Annual Procurement Plan/Updated Project Procurement Management Plan of the TPB for 2021;

**WHEREAS**, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA 9184);

**WHEREAS**, in accordance with the provisions of Section 53.9 of the RIRR of RA 9184, the procuring entity may resort to Small Value Procurement, where the amount involved does not exceed the threshold prescribed in Annex “H” of the aforementioned RIRR, provided that in case of Goods, the procurement does not fall under Shopping (Sec.52 of RIRR);

**WHEREAS**, the Bids and Awards Committee (BAC), thru its Secretariat, has undertaken the following activities:

1. Posted the Request for Quotation (RFQ) No. TPB-PR.2021.08.298 in the Philippine Government Electronic Procurement System (PhilGEPs) and TPB

Website on August 13, 2021 and set the deadline of submission of bids on August 18, 2021;

2. Invited Bidders to submit quotation on August 13, 2021;
3. Received quotation from the following bidders:
  - a) Marclyn Merchandising;
  - b) Silverice Trading Corp.

**WHEREAS**, the technical evaluators for Alternative Methods of Procurement reviewed and evaluated the legal aspect of the submitted quotations by the bidders on August 18, 2021;

**WHEREAS**, the Rice Committee Members evaluated the rice sample submitted by the bidders on August 18, 2021 are as follows:
