

**BIDS AND AWARDS COMMITTEE
RESOLUTION NO. 2021-300**

DECLARING INTAS DESTINATION MANAGEMENT, INC., AS A LOWEST CALCULATED AND RESPONSIVE BID (LCRB) FOR LOT 1 AND LOT 2 FOR THE PROCUREMENT OF SERVICES OF TOUR OPERATOR FOR THE ISLAND PHILIPPINES CARAVAN

WHEREAS, the Tourism Promotions Board (TPB), through its Bids and Awards Committee (BAC), posted the Invitation to Bid No. TPB-ITB No. 2021-012 for the Procurement of **Services of Tour Operator for the Island Philippines Caravan** with a total Approved Budget for the Contract (ABC) of **Three Million Fifty-Seven Thousand Six Hundred Pesos Only (Php3,057,600.00)** in the TPB website (www.tpb.gov.ph), the PhilGEPS and conspicuous place at the premises of TPB Bulletin Board for twenty-one (21) days;

The requirement is broken down into the following lots:

WHEREAS, on August 19, 2021, the Bids and Awards Committee (BAC) held the pre-bid conference which was attended by the following prospective bidders:

WHEREAS, the BAC, through its BAC Secretariat issued a Supplemental Bid Bulletin No. 2021-064 dated August 20, 2021 and posted in PhilGEPS, and TBP website for the purposes of modifications and/or clarification made during the pre-bid conference;

WHEREAS, on August 30, 2021, Intas Destination Management, Inc., and Shroff International Travel Care, Inc., submitted their bids proposal for Lot 1 and Lot 2;

WHEREAS, on August 31, 2021, Anset Holidays, Inc., submitted their bids proposal for Lot 1 only before the prescribed closing time on August 31, 2021;

WHEREAS, on August 31, 2021, during the opening of the bid for Lot 1, the BAC Members, Project Officer, and the Technical Working Group (TWG) examined the bid proposal submitted by Intas Destination Management, Inc., Shroff International Travel Care, Inc., and Annset Holidays, Inc. using non-discretionary “pass/fail” criteria.

WHEREAS, upon examination of the submitted bid proposal, the BAC Members declared the bids of Intas Destination Management, Inc., Shroff International Travel Care, Inc., and Annset Holidays, Inc. to be **Compliant and Eligible** for **Lot 1**.

WHEREAS, the BAC proceeded to open the financial proposal submitted by Intas Destination Management Inc., Shroff International Travel Care, Inc., and Annset Holidays, Inc. for Lot 1 and as read as follows:

WHEREAS, upon examination of the submitted bid proposal, the BAC Members declared the bids of Intas Destination Management, Inc. and Shroff International Travel Care, Inc., to be **Compliant and Eligible** for **Lot 2**.

WHEREAS, the BAC proceeded to open the financial proposal submitted by Intas Destination Management Inc. and Shroff International Travel Care, Inc., for Lot 2 and as read as follows:

NOW THEREFORE, for and in consideration of the foregoing, we, the member of the Bids and Awards Committee hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

- a) to **DECLARE** Intas Destination Management Inc.,’s bid for **Lot 1 and Lot 2** for the Services of Tour Operator for the Island Philippine Caravan as a **Lowest Calculated Responsive Bid (SCRB)**; and
- b) to **RECOMMEND** for approval of the **Chief Operating Officer of the Tourism Promotions Board** to **AWARD** to **Intas Destination Management Inc.**, the **contract for Lot 1 and Lot 2** for the **Services of Tour Operator for the Island Philippine Caravan** in the amount of **One Million Two Hundred Thirty-Seven Thousand One Hundred Eighty Pesos (PhP1,237,180.00)** inclusive of all applicable taxes for **Lot 1** and **One Million Five Hundred Forty-Four Thousand Six Hundred Seventy Pesos (PhP1,544,670.00)** inclusive of all applicable taxes for **Lot 2**.
