RECOMMENDING AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT TO RBHC COURIER SERVICE FOR DOOR TO DOOR COURIER SERVICE OF PROMOTIOANAL MATERIALS TO THE PHILIPPINE OVERSEAS LABOR OFFICE IN TORONTO ONTARIO CANADA

WHEREAS, there is an approved Purchase Request (PR) No.8.040 with an Approved Budget for the Contract (ABC) of Thirty-three Thousand Pesos Only (PhP33,100.00), for Door to door courier service of promotional materials to the Philippine Overseas Labor Office in Toronto, Ontario Canada;

WHEREAS, said item is included in the Annual Procurement Plan/Updated Project Procurement Management Plan of the TPB for 2021;

WHEREAS, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA 9184);

WHEREAS, in accordance with the provisions of Section 53.9 of the RIRR of RA 9184, the procuring entity may resort to Small Value Procurement, where the amount involved does not exceed the threshold prescribed in Annex "H" of the aforementioned RIRR, provided that in case of Goods, the procurement does not fall under Shopping (Sec.52 of RIRR);

WHEREAS, the Bids and Awards Committee (BAC), thru its Secretariat, has undertaken the following activities:

- 1. Posted the Request for Quotation (RFQ) No. TPB-PR.2021.08.323 in the Philippine Government Electronic Procurement System (PhilGEPS) and TPB Website on August 31, 2021 and set the deadline of submission of bids on September 10, 2021;
- 2. Invited suppliers on August 31, 2021;
- 3. Received quotations from the following bidders:
 - a) Blue Chip Marketing
 - b) RBHC Courier Service
 - c) EMR Courier Services International Inc.



WHEREAS, the technical evaluators for Alternative Methods of Procurement and the Project Officer reviewed and evaluated the Legal and Technical aspect of the submitted quotations on September 10, 2021 as follows:
