

**BIDS AND AWARDS COMMITTEE  
RESOLUTION NO. 2021-306**

**DECLARING TANJER ENTERPRISES AS A SINGLE CALCULATED RESPONSIVE BID (SCRB) FOR LOT 1, LOT 3, LOT 4, AS A LOWEST CALCULATED RESPONSIVE BID (LCRB) FOR LOT 2 AND A FAILURE OF BIDDING AND TO RE-BID FOR LOT 5 FOR THE PROCUREMENT OF CORPORATE GIVEAWAYS AND COLLATERALS INCLUSIVE OF STORAGE, COURIER AND PACKAGING FOR THE PHILIPPINE MOTORCYCLE TOURISM PROGRAM**

**WHEREAS**, there is an approved Purchase Request (PR) No. 7.016 with an Approved Budget for the Contract (ABC) of **Five Million Pesos (PhP5,000,000.00)** for the **Corporate giveaways and collaterals inclusive of storage, courier and packaging for the Philippine Motorcycle Tourism Program for a total of 5 Lots;**

**WHEREAS**, the said item is included in the Annual Procurement/Updated Project Procurement Management Plan of the TPB for 2021;

**WHEREAS**, the Tourism Promotions Board (TPB), through its Bids and Awards Committee (BAC), posted the Invitation to Bid No. TPB-ITB No. 2021-009 for the Procurement of **Corporate giveaways and collaterals inclusive of storage, courier and packaging for the Philippine Motorcycle Tourism Program** with a total Approved Budget for the Contract (ABC) of **Five Million Pesos Only (Php5,000,000.00)** on the TPB website ([www.tpb.gov.ph](http://www.tpb.gov.ph)), the PhilGEPS and conspicuous place at the premises of TPB Bulletin Board for twenty-one (21) days;

**WHEREAS**, on August 19, 2021, the Bids and Awards Committee (BAC) held the pre-bid conference, which was attended by the following prospective bidders:

- 6) Tanjer Enterprises – Ms. Angelica Tan

**WHEREAS**, the BAC, through its BAC Secretariat, issued a Supplemental Bid Bulletin No. 2021-063 dated August 20, 2021, and posted on PhilGEPS and TBP website for the purposes of modifications and/or clarification made during the pre-bid conference;

**WHEREAS**, on August 30, 2021, Tanjer Enterprises submitted their bids proposal for Lot 1, Lot 2, Lot 3, and Lot 4;

**WHEREAS**, on August 30, 2021, Jaja Trading submitted their bids proposal for Lot 2 only;

**WHEREAS**, the BAC Secretariat did not receive a bid proposal for Lot 5;

**WHEREAS**, on August 31, 2021, during the opening of the bid for Lot 1, Lot 2, Lot 3, and Lot 4, the BAC Members, Project Officer, and the Technical Working Group (TWG) examined the bid proposal submitted by Tanjer Enterprises and Jaja Trading using non-discretionary “pass/fail” criteria.

**WHEREAS**, the BAC Members declared the bids of Tanjer Enterprises and Jaja Trading as **Compliant and Eligible**.

**WHEREAS**, the BAC proceeded to open the financial proposal submitted by Tanjer Enterprises and Jaja Trading and as read as follows:

**WHEREAS**, upon careful examination, validation and verification of all the eligibility, legal, technical, and financial documents presented during post-qualification on September 20, 2021, the BAC-TWG and with concurrence of the BAC, found that the bid of Tanjer Enterprises for Lot 1, Lot 2, Lot 3, and Lot 4 are compliant and responsive;

**NOW THEREFORE**, for and in consideration of the foregoing, we, the member of the Bids and Awards Committee hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

- a) to **DECLARE** Tanjer Enterprises bids for **Lot 1, Lot 3, and Lot 4** of the Procurement of Corporate Giveaways and Collaterals inclusive of storage, packaging and courier services for Philippine Motorcycle Tourism Program as a **Single Calculated Responsive Bid (SCRB)**;
- b) to **DECLARE** Tanjer Enterprises bid for **Lot 2** of the Procurement of Corporate Giveaways and Collaterals inclusive of storage, packaging and courier services for Philippine Motorcycle Tourism Program as the **Lowest Calculated Responsive Bid (LCRB)**;
- c) to **DECLARE FAILURE OF BIDDING** for **Lot 5** of the Procurement of Corporate Giveaways and Collaterals inclusive of storage, packaging and courier services for Philippine Motorcycle Tourism Program;
- d) to **CONDUCT** the procurement of Corporate Giveaways and Collaterals inclusive of storage, packaging and courier services for Philippine Motorcycle Tourism Program for **Lot 5** through Small Value Procurement in accordance with the pertinent procurement rules and regulations under the R.A. 9184 and its RIRR and related GPPB issuances;
- e) to **RECOMMEND** for approval of the Chief Operating Officer of the TPB to **AWARD** the Contract to **Tanjer Enterprises** for Lot 1, Lot 2, Lot 3, and Lot 4 for the **Corporate giveaways and collaterals inclusive of storage, packaging and courier services for Philippine Motorcycle Tourism Program** in the following amount:
