RESOLUTION NO. 2021-330**

**RECOMMENDING AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT
TO EMR COURIER SERVICES INTERNATIONAL INC. FOR THE PACKAGING, STORAGE
AND COURIER OF COLLATERAL AND GIVEAWAYS FOR THE PHILIPPINE MOTORCYCLE
TOURISM PROGRAM**

WHEREAS, there is an approved Purchase Request No. 7.016 with an Approved Budget for the Contract (ABC) of **Five Million Pesos (Php5,000,000.00)** for the **Giveaways and Collaterals, inclusive of packaging, storage, and courier relative to the Philippine Motorcycle Tourism Program**, broken down into five (5) lots-

WHEREAS, on September 21, 2021, the Chief Operating Officer of Tourism Promotions Board **approved** the Bids and Award Committee (BAC) Resolution No. 2021-306 with the following details:

- a) to *DECLARE* *Tanjer Enterprises bids for Lot 1, Lot 3, and Lot 4 of the Procurement of Corporate Giveaways and Collaterals inclusive of storage, packaging and courier services for Philippine Motorcycle Tourism Program as a Single Calculated Responsive Bid (SCRB);*
- b) to *DECLARE* *Tanjer Enterprises bid for Lot 2 of the Procurement of Corporate Giveaways and Collaterals inclusive of storage, packaging and courier services for Philippine Motorcycle Tourism Program as the Lowest Calculated Responsive Bid (LCRB);*
- c) to **DECLARE FAILURE OF BIDDING** *for Lot 5 of the Procurement of Corporate Giveaways and Collaterals inclusive of storage, packaging and courier services for Philippine Motorcycle Tourism Program;*
- d) to **CONDUCT** *the procurement of Corporate Giveaways and Collaterals inclusive of storage, packaging and courier services for Philippine*

*Motorcycle Tourism Program for **Lot 5** through Small Value Procurement in accordance with the pertinent procurement rules and regulations under the R.A. 9184 and its RIRR and related GPPB issuances;*

- e) *to RECOMMEND for approval of the Chief Operating Officer of the TPB to AWARD the Contract to Tanjer Enterprises for Lot 1, Lot 2, Lot 3, and Lot 4 for the Corporate giveaways and collaterals inclusive of storage, packaging and courier services for Philippine Motorcycle Tourism Program;*

WHEREAS, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (R.A.) 9184;

WHEREAS, in accordance with the provisions of Section 53.9 of the RIRR of RA 9184, the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex "H" of the RIRR, provided that in case of Goods, the procurement does not fall under Shopping in Section 52 of the RIRR;

WHEREAS, the BAC Secretariat, posted the Request for Quotation (TPB-PR 2021.09.363) dated September 30, 2021 on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on October 5, 2021;

WHEREAS, RBHC Courier Service, EMR Courier Services International Inc., Impextic Inc., Soonest Global Express Corporation submitted their bid proposal before the deadline of submission;

WHEREAS, the Technical Evaluators for Alternative Methods of Procurement opened the submitted quotations on October 5, 2021, *with the following details*:
