**DECLARING TRANSPRINT CORPORATION AS A LOWEST CALCULATED RESPONSIVE
BID (LCRB) AND TO AWARD THE CONTRACT FOR PRINTING OF BUCKET LIST COFFEE
BOOK EDITION 3**

WHEREAS, there is an approved Purchase Request (PR) **No. 8.041** with an approved Budget for the Contract (ABC) of **Five Million Pesos (Php5,000,000.00)**, for the **Printing of Bucket List Coffee Table Book Edition 3**;

WHEREAS, said item is included in the Annual Procurement Plan/Updated Project Procurement Management Plan of the Tourism Promotions Board (TPB) for 2021;

WHEREAS, the TPB, through its Bids and Awards Committee (BAC), posted the Invitation to Bid No. TPB-ITB No. 2021-015 for the **Printing of Bucket List Coffee Table Book Edition 3** with a total Approved Budget for the Contract (ABC) of **Five Million Pesos (Php5,000,000.00)** in the TPB website (www.tpb.gov.ph), the PhilGEPS and conspicuous place at the premises of TPB Bulletin Board for twenty-one (21) days;

WHEREAS, on September 22, 2021, the Bids and Awards Committee (BAC) held the pre-bid conference which was attended by the following prospective bidders:

- 1) Transprint Corporation – Ms. Christelle Y. Arceo
- 2) The House of Printers Corporation – Ms. Clarita P. Terrado

WHEREAS, the BAC, through its BAC Secretariat issued a Supplemental Bid Bulletin No. 2021-078 dated September 23, 2021 and posted in PhilGEPS, and TBP website for the purposes of modifications and/or clarification made during the pre-bid conference;

WHEREAS, on **October 2, 2021**, Transprint Corporation and The House Printers Corporation submitted their bids proposal before the set deadline of submission;

WHEREAS, on **October 4, 2021**, during the opening of the bid for the Printing of Bucket List Coffee Table Book Edition 3 the BAC Members, Project Officer, and the Technical Working Group (TWG) examined the bid proposal submitted by suppliers using non-discretionary “pass/fail” criteria;

WHEREAS, the BAC Members declared the bids of Transprint Corporation and The House Printers Corporation as **Compliant and Eligible**;

WHEREAS, the BAC proceeded to open the financial proposal submitted by Transprint Corporation and The House Printers Corporation and as read as follows:

- b) to **RECOMMEND** for approval of the Chief Operating Officer of the TPB to **AWARD** the Contract to **Transprint Corporation** for **Printing of Bucket List Coffee Table Book Edition 3** in the amount of **Four Million Three Hundred Thousand Thirty Pesos (Php4,300,030.00)** inclusive of all applicable taxes.


