**RECOMMENDING AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT
TO VINTEL LOGISTICS, INC. FOR THE PACKAGING AND SHIPMENT OF GIVEAWAYS
TO TOKYO, JAPAN FOR THE PHILIPPINE BUSINESS MISSION**

WHEREAS, there is an approved Purchase Request (PR) No. 8.045 with an Approved Budget for the Contract (ABC) of **Two Hundred Thousand Pesos (PhP200,000.00)**, for the **packaging and shipment of corporate giveaways to the Philippine Department of Tourism Office in Tokyo, Japan in connection with the Philippine Business Mission 2021;**

WHEREAS, said item is included in the Annual Procurement Plan/Updated Project Procurement Management Plan of the TPB for 2021;

WHEREAS, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (R A) No. 9184;

WHEREAS, in accordance with the provisions of Section 53.9 of the RIRR of RA 9184, the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex “H” of the RIRR, provided that in case of Goods, the procurement does not fall under Shopping in Section 52 of the RIRR;

WHEREAS, the Bids and Awards Committee (BAC) Secretariat posted the Request for Quotation (TPB-PR 2021.09.349) dated September 14, 2021 on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on September 20, 2021;

WHEREAS, RBHC Courier Service, and Vintel Logistics, Inc. submitted their bid proposal before the deadline of submission;

WHEREAS, the Technical Evaluators for Alternative Methods of Procurement opened the submitted quotations on September 20, 2021, *with the following details:*




