**RECOMMENDING AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT  
TO TOTAL EXHIBIT AND EXPO SOLUTIONS, INC. FOR THE SERVICE PROVIDER OF A  
HYBRID WEBINAR AND ENTERTAINMENT**

**WHEREAS**, there is an approved Purchase Request (PR) No. 9.002 with an Approved Budget for the Contract (ABC) of **One Million Pesos (PhP1,000,000.00)**, for the **Service Provider of a Hybrid Webinar and Entertainment for Philippine Motorcycle Tourism program**;

**WHEREAS**, said item is included in the Annual Procurement Plan/Updated Project Procurement Management Plan of the TPB for 2021;

**WHEREAS**, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) 9184;

**WHEREAS**, in accordance with the provisions of Section 53.9 of the RIRR of RA 9184, the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex "H" of the RIRR, provided that in case of Goods, the procurement does not fall under Shopping in Section 52 of the RIRR;

**WHEREAS**, the Bids and Awards Committee (BAC) - Secretariat, posted the Request for Quotation (TPB-PR 2021.09.331) dated September 3, 2021 on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on September 10, 2021;

**WHEREAS**, Total Exhibit and Expo Solutions, Inc., Masaya Studio, Inc., and Post Ad Ventures Inc., submitted their bid proposal before the deadline of submission;

**WHEREAS**, the Technical Evaluators for Alternative Methods of Procurement opened the submitted quotations on September 10, 2021, *with the following details*:






