RESOLUTION NO. 2021-315**

**RECOMMENDING AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT
TO RBHC COURIER SERVICE FOR THE PACKAGING AND DOOR TO DOOR DELIVERY
OF PHITEX SELLER DELEGATE KITS**

WHEREAS, there is an approved Purchase Request (PR) No. 9.011 with an Approved Budget for the Contract (ABC) of **Seven Hundred Fifty Thousand Pesos (PhP750,000.00)** for the **Packaging and door to door delivery of PHITEX 2021 Seller Delegate Kits**;

WHEREAS, said item is included in the Annual Procurement Plan/Updated Project Procurement Management Plan of the TPB for 2021;

WHEREAS, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) No. 9184;

WHEREAS, in accordance with the provisions of Section 53.9 of the RIRR of RA 9184, the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex “H” of the RIRR, provided that in case of Goods, the procurement does not fall under Shopping in Section 52 of the RIRR;

WHEREAS, the Bids and Awards Committee (BAC) - Secretariat posted the Request for Quotation (TPB-PR 2021.09.350) dated September 14, 2021 on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on September 20, 2021;

WHEREAS, First Ambassador Logistic Solutions, Inc., Impextic Inc., Panthertech Freight Forwarder and Premium Courier Express Int’l Inc., RBHC Courier Service, and Vintel Logistics, Inc. submitted their bid proposal before the deadline of submission;

WHEREAS, the Technical Evaluators for Alternative Methods of Procurement opened the submitted quotations on September 20, 2021, *with the following details*:


