RE: RESULT OF THE VALIDATION OF THE IATF REQUIREMENTS FOR THE 2019 PBB

Dear Secretary Puyat and COO Velasco-Allones,

This is to formally transmit the Result of the Validation of Good Governance Conditions (GGCs), Support to Operations (STOs), General Administration and Support Services (GASS) and Other Cross-Cutting Requirements provided by the Inter-Agency Task Force (IATF) of the Harmonization of National Government Performance Monitoring, Information and Reporting Systems (*Annex A*), which enumerates the final non-compliant agencies who failed to meet the IATF requirements for the grant of the 2019 Performance-Based Bonus (PBB).

Based on the List of Non-Compliant GOCCs covered by Republic Act No. 10149, TPB was found to be non-compliant with the following:

Good Governance Conditions

PhilGEPS

Other Cross-Cutting Requirements

• FY 2018 APCPI Submission

Under Item 4.2. of GCG Memorandum Circular (M.C.) No. 2019-02,¹ a GOCC must satisfy 100% of the Good Governance Conditions and all other compliances required under the applicable IATF Memorandum Circular to be eligible to grant the PBB to its qualified officers and employees.

In this regard, TPB fails to satisfy the requirements of GCG M.C. No. 2019-02, particularly on the compliance to the Good Governance Conditions. Thus, the corporation is considered **INELIGIBLE** to grant the 2019 PBB.

We also take this opportunity to remind the Board that any unilateral action to release the PBB will be considered as a violation of the Board's fiduciary duty to protect the assets of the GOCC as provided under Section 19 of Republic Act No. 10149.<sup>2</sup>

Consequently, pursuant to GCG M.C. No. 2018-04,<sup>3</sup> failure to qualify for the PBB means that the Appointive Members of the Governing Board of TPB shall not be qualified to receive the Performance-Based Incentive (PBI).
