RECOMMENDING SINGLE RATED RESPONSIVE BID (SRRB) AND TO AWARD THE CONTRACT TO TOTAL EXHIBIT AND EXPO SOLUTIONS, INC. FOR THE SERVICES OF AN EVENT MANAGEMENT COMPANY FOR THE ASSOCIATIONS SUMMIT 9th EDITION

WHEREAS, there is an approved Purchase Request (PR) No. 10.024 with an Approved Budget for the Contract (ABC) of **ONE MILLION PESOS (PhP1,000,000.00)**, for the Services of an Event Management Company for the Associations Summit 9th Edition;

WHEREAS, the said project is included in the Updated Project Procurement Management Plan of the MICE Department and the Annual Procurement Plan Updated of the TPB for Fiscal Year 2021;

WHEREAS, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (R.A.) No. 9184;

WHEREAS, in accordance with the provisions of Section 53.9 of the RIRR of RA 9184, the procuring entity may resort to Small Value Procurement, where the amount involved does not exceed the threshold prescribed in Annex “H” of the aforementioned RIRR, provided that in case of Goods, the procurement does not fall under Shopping (Section 52 of RIRR);

WHEREAS, the Bids and Award Committee (BAC) Secretariat invited the **Ex-Link Management and Marketing Services, Peptarsus Corporation, Team Asia, and Total Exhibit and Expo Solutions, Inc. (TEESI)** to submit a bid proposal and posted the Request for Proposal (TPB-PR 2021.10.386) dated October 19, 2021 on the PhilGEPS website and TPB website with the deadline of submission of bid on October 27, 2021;

WHEREAS, the BAC Secretariat received bid proposal from the lone bidder, **TEESI**, before the set deadline of submission;

WHEREAS, the project officer and the technical evaluators for the Alternative Method of Procurement opened the submitted bid proposal on October 28, 2021, with the following details:
