**RECOMMENDING AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT  
TO RBHC COURIER SERVICE FOR THE COURIER SERVICES OF CORPORATE GIVEAWAYS  
FOR THE MICECONNECT PROJECT**

**WHEREAS**, there is an approved Purchase Request (PR) No. 10.047 with an Approved Budget for the Contract (ABC) of **One Hundred Seven Thousand Pesos (PhP107,000.00)**, for the **courier services of corporate giveaways for the MICECONnect 2021 project**;

**WHEREAS**, said item is included in the Annual Procurement Plan/Updated Project Procurement Management Plan of the TPB for 2021;

**WHEREAS**, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA 9184);

**WHEREAS**, in accordance with the provisions of Section 53.9 of the RIRR of RA 9184, the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex “H” of the RIRR, provided that in case of Goods, the procurement does not fall under Shopping in Section 52 of the RIRR;

**WHEREAS**, the Bids and Awards Committee (BAC) - Secretariat, posted the Request for Quotation (TPB-PR 2021.10.408) dated October 29, 2021 on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on November 3, 2021;

**WHEREAS**, the following bidders submitted their bid proposal before the deadline of submission: 1.) RBHC Courier Service 2.) EMR Courier Services International Inc. 3.) Impextic Inc. 4.) 1<sup>st</sup> Ambassador Logistics Solutions Inc.

**WHEREAS**, the Technical Evaluators for Alternative Methods of Procurement opened the submitted quotations on November 3, 2021, *with the following details*:
