RECOMMENDING AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT TO RBHC COURIER SERVICE FOR INTERNATIONAL AND LOCAL COURIER AND MESSENGERIAL SERVICES OF 2022 DESK AND WALL CALENDAR

WHEREAS, there is an approved Purchase Request (PR) No. 10.030 with an Approved Budget for the Contract (ABC) of Seven Hundred Forty Thousand Pesos (PhP740,000.00), for the International and local courier and messengerial services of 2022 Desk and Wall calendar;

WHEREAS, said item is included in the Annual Procurement Plan/Updated Project Procurement Management Plan of the TPB for 2021;

WHEREAS, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA 9184);

WHEREAS, in accordance with the provisions of Section 53.9 of the RIRR of RA 9184, the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex "H" of the RIRR, provided that in case of Goods, the procurement does not fall under Shopping in Section 52 of the RIRR;

WHEREAS, the Bids and Awards Committee (BAC) - Secretariat, posted the Request for Quotation (TPB-PR 2021.10.400) dated October 22, 2021 on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on October 28, 2021;

WHEREAS, Blue Chip Marketing, RBHC Courier Service, Impextic Inc., and K5 Plus Logistics Corp. submitted their bid proposal before the deadline of submission;

WHEREAS, the Technical Evaluators for Alternative Methods of Procurement opened the submitted quotations on October 28, 2021, *with the following details*:
