AS A LOWEST CALCULATED RESPONSIVE BID (LCRB) FOR LOT 2 & 6, AND SINGLE CALCULATED RESPONSIVE BID (SCRB) FOR LOT 3, 4 & 5 FOR THE SERVICES OF TOUR OPERATOR FOR THE ONLINE TRAVEL BINGO CHALLENGE SEASON 2

**WHEREAS**, the said item is included in the Annual Procurement/Updated Project Procurement Management Plan of the TPB for 2021;

WHEREAS, the Tourism Promotions Board (TPB), through its Bids and Awards Committee (BAC), posted the Invitation to Bid No. TPB-ITB No. 2021-024 for the Services of Tour Operator for the Online Travel Bingo Challenge Season 2 for a total of 6 Lots with a total Approved Budget for the Contract (ABC) of Seven Million Pesos (Php7,000,000.00) in the TPB website (www.tpb.gov.ph), the PhilGEPS and conspicuous place at the premises of TPB Bulletin Board for twenty-one (21) days;



**WHEREAS,** on November 12, 2021, the Bids and Awards Committee (BAC) held the pre-bid conference which was attended by the following prospective bidders:

- 1) Ms. Sarah May Marasigan Shroff International Travel Care, Inc.
- 2) Mr. Antonio Esteban Mooncake Educational Travel and Tours
- 3) Ms. Ma. Angelica P. Faustino CCT 168 Travel and Tours Corp.

**WHEREAS,** the BAC, through its BAC Secretariat issued a Supplemental Bid Bulletin No. 2021-093 dated November 4, 2021 announcing the Zoom Link of Pre Bid and Bid Opening Conference and posted in PhilGEPS, and TPB website.

**WHEREAS,** on November 24, 2021, Shroff International Travel Care, Inc. submitted their bids proposal for Lot 1 to 6;

**WHEREAS,** on November 25, 2021, Annset Holidays, Inc. and Mooncake Educational Travel and Tours submitted their bids proposal for Lot 1-3, and Lot 6 before the prescribed closing time on November 25, 2021;

WHEREAS, on November 25, 2021, during the opening of the bids the BAC Members, Project Officer, and the Technical Working Group (TWG) examined the bid proposal submitted by Shroff International Travel Care, Inc., Annset Holidays, Inc. and Mooncake Educational Travel and Tours using non-discretionary "pass/fail" criteria;

**WHEREAS,** for Lot 1 & 2 the BAC Members declared the bids of Shroff International Travel Care, Inc. and Annset Holidays, Inc. as **Compliant and Ineligible** while Mooncake Educational Travel and Tours as **Non-Compliant and Ineligible**;

**WHEREAS,** for Lot 3 the BAC Members declared the bids of Shroff International Travel Care, Inc. as **Compliant and Ineligible** while Annset Holidays, Inc. and Mooncake Educational Travel and Tours as **Non-Compliant and Ineligible**;

**WHEREAS,** for Lot 4 & 5 the BAC Members declared the bids of Shroff International Travel Care, Inc. as **Compliant and Ineligible**;

WHEREAS, for Lot 6 the BAC Members declared the bids of Shroff International Travel Care, Inc. and Annset Holidays, Inc. as **Compliant and Ineligible** while Mooncake Educational Travel and Tours as **Non-Compliant and Ineligible**;

**WHEREAS**, the BAC proceeded to open the financial proposal submitted by Shroff International Travel Care, Inc. and Annset Holidays, Inc. and as read as follows:

WHEREAS, upon careful examination, validation and verification of all the eligibility, legal, technical, and financial documents presented during post-qualification on December 17, 2021, the BAC-TWG and with concurrence of the BAC, found that the bid of Annset Holidays, Inc. for Lot 1 are compliant and responsive and the bid of Shroff International Travel Care, Inc. for Lot 2 to 6 are also compliant and responsive;

**NOW THEREFORE**, for and in consideration of the foregoing, we, the member of the Bids and Awards Committee hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:

- a) to **DECLARE** Annset Holidays, Inc. bids for **Lot 1**, for the Services of Tour Operator for the Online Travel Bingo Challenge Season 2 as a **Lowest Calculated Responsive Bid (LCRB)**;
- b) to DECLARE Shroff International Travel Care, Inc. bids for Lot 2, & 6 for the Services of Tour Operator for the Online Travel Bingo Challenge Season 2 as a Lowest Calculated Responsive Bid (LCRB);

- c) to DECLARE Shroff International Travel Care, Inc. bids for Lot 3, 4 & 5 for the Services of Tour Operator for the Online Travel Bingo Challenge Season 2 as a Single Calculated Responsive Bid (SCRB);
- d) to RECOMMEND for approval of the Chief Operating Officer of the TPB the AWARD to Annset Holidays, Inc. the contract for Lot 1 and to Shroff International Travel Care, Inc. the contract for Lot 2 to 6 for the Services of Tour Operator for the Online Travel Bingo Challenge Season 2 in the following amount:
