**DECLARING RBHC COURIER SERVICE AS A LOWEST CALCULATED RESPONSIVE BID
(LCRB) AND TO AWARD THE CONTRACT FOR INTERNATIONAL AND LOCAL DOOR TO
DOOR COURIER AND MESSENGERIAL SERVICES OF BUCKET LIST COFFEE TABLE
BOOK EDITION 3**

WHEREAS, there is an approved Purchase Request (PR) **No. 8.042** with an approved Budget for the Contract (ABC) of **Three Million Eight Hundred Twenty-four Thousand Two Hundred Pesos (Php3,824,200.00)**, for **International and Local Courier and Messengerial Services of Bucket List Coffee Table Book Edition 3**;

WHEREAS, said item is included in the Annual Procurement Plan/Updated Project Procurement Management Plan of the Tourism Promotions Board (TPB) for 2021;

WHEREAS, the TPB, through its Bids and Awards Committee (BAC), posted the **Invitation to Bid No. TPB-ITB No. 2021-023** for the **International and Local Courier and Messengerial Services of Bucket List Coffee Table Book Edition 3** with a total Approved Budget for the Contract (ABC) of **Three Million Eight Hundred Twenty-Four Thousand Two Hundred Pesos (Php3,824,200.00)**, in the TPB website (www.tpb.gov.ph), the PhilGEPS and conspicuous place at the premises of TPB Bulletin Board for twenty-one (21) days;

WHEREAS, on November 11, 2021, the Bids and Awards Committee (BAC) held the pre-bid conference which was attended by the following prospective bidders:

- 1) 2GO Express Inc. – Ms. Therese Brenbicar R. Tacorda
- 2) V Cargo Worldwide Inc. – Mr. Josept S. Javier
- 3) Airspeed – Ms. Krystal Gay Rom Octaviano

WHEREAS, the BAC, through its BAC Secretariat issued a Supplemental Bid Bulletin No. 2021-095 dated November 11, 2021 and posted in PhilGEPS, and TBP website for the purposes of modifications and/or clarification made during the pre-bid conference;

WHEREAS, on November 22, 2021, 2GO Express Inc. submitted their bids proposal;

WHEREAS, on November 23, 2021, RBHC Courier Services submitted their bids proposal before the set deadline of submission;

WHEREAS, on November 23, 2021, during the opening of the bid for the International and Local Courier and Messengerial Services of Bucket List Coffee Table Book Edition 3 the BAC Members, Project Officer, and the Technical Working Group (TWG) examined the bid proposal submitted by the suppliers using non-discretionary “pass/fail” criteria.

WHEREAS, the BAC Members declared the bids of 2GO Express Inc. and RBHC Courier Service as **Compliant and Eligible**.

WHEREAS, the BAC proceeded to open the financial proposal submitted by 2GO Express Inc. and RBHC Courier Service and as read as follows:

- b) to **RECOMMEND** for approval of the Chief Operating Officer of the TPB to **AWARD** the Contract to **RBHC Courier Service** for **International and Local Courier and Messengerial Services of Bucket List Coffee Table Book Edition 3** in the amount of **Two Million Nine Hundred Ninety-Four Thousand Three Hundred Forty-Six Pesos (Php2,994,346.00)** inclusive of all applicable taxes.
