**RECOMMENDING AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT  
TO PANTHERTECH FREIGHT FORWARDER AND PREMIUM COURIER EXPRESS INT’L  
CORP. FOR THE PACKAGING AND COURIER SERVICE OF 500 YEARS OF  
CHRISTIANITY COMMEMORATIVE PLATES WITH CASING**

**WHEREAS**, there is an approved Purchase Request (PR) No. 10.045 with an Approved Budget for the Contract (ABC) of **One Hundred Forty-One Thousand Nine Hundred Eighty Pesos (PhP141,980.00)**, for the **packaging and courier service of 500 Years of Christianity (YOC) Commemorative Plates with Casing**;

**WHEREAS**, said item is included in the Updated Project Procurement Management Plan/Annual Procurement Plan of the TPB for 2021;

**WHEREAS**, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA 9184);

**WHEREAS**, in accordance with the provisions of Section 53.9 of the RIRR of RA 9184, the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex “H” of the RIRR, provided that in case of Goods, the procurement does not fall under Shopping in Section 52 of the RIRR;

**WHEREAS**, the Bids and Awards Committee (BAC) - Secretariat, posted the Request for Quotation (TPB-PR 2021.11.422) dated November 9, 2021 on the PhilGEPs and TPB Websites with a *deadline* of submission of bids on November 15, 2021;

**WHEREAS**, Panthertech Freight Forwarder and Premium Courier Express Int’l Corp. submitted their bid proposal before the deadline of submission;

**WHEREAS**, the Technical Evaluators for Alternative Methods of Procurement opened the submitted quotations on November 15, 2021, *with the following details*:


