## RECOMMENDING AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT TO IMPEXTIC, INC. FOR OVERSEAS SHIPMENT SERVICES FOR THE PHILIPPINE TRAVEL EXCHANGE 2021 HYBRID EDITION

WHEREAS, there is an approved Purchase Request (PR) No. 8.010 with an Approved Budget for the Contract (ABC) of Nine Hundred Ninety-Eight Thousand Pesos Only (PhP998,000.00), for the Overseas Shipment Services for the Philippine Travel Exchange (PHITEX) 2021 Hybrid Edition;

**WHEREAS**, said item is included in the Annual Procurement Plan/Updated Project Procurement Management Plan of the TPB for 2021;

**WHEREAS**, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA 9184);

**WHEREAS,** in accordance with the provisions of Section 53.9 of the RIRR of RA 9184, the procuring entity may resort to Small Value Procurement, where the amount involved does not exceed the threshold prescribed in Annex "H" of the aforementioned RIRR, provided that in case of Goods, the procurement does not fall under Shopping (Sec.52 of RIRR);

**WHEREAS,** the Bids and Awards Committee (BAC) – Secretariat, posted the Request for Quotation (TPB-PR 2021.11.429) dated November 18, 2021, on the PhiGEPS and TPB Website with a deadline of submission of bids on November 25, 2021;

**WHEREAS,** Impextic, Inc. submitted their bid proposal before the deadline of submission;

**WHEREAS,** the technical evaluators for Alternative Methods of Procurement opened the submitted quotation on November 25, 2021, with the following details:
