CONTRACT AGREEMENT

THIS AGREEMENT made and entered into the City of Manila, Philippines, this 29 day of ________, 2021 between the TOURISM PROMOTIONS BOARD, a Government Owned and Controlled Corporation, with principal address at 4th Floor, Legaspi Towers 300, Roxas Boulevard, Manila, Philippines, herein represented by its Chief Operating Officer, MARIA ANTHONETTE C. VELASCO-ALLONES, hereinafter called the "ENTITY" of the one part, and RBHC Courier Service, a business entity duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with business address at 3190 F. Roxas St., Sta. Ana Manila, herein represented by its sole proprietor, MR. BRENDON JAY A. CORNES, hereinafter called the "SUPPLIER".

WHEREAS, the ENTITY invited Bids for certain goods and ancillary services, particularly PACKAGING AND INTERNATIONAL AND LOCAL DOOR TO DOOR COURIER AND MESSENGERIAL SERVICES OF BUCKET LIST COFFEE TABLE BOOK EDITION 3 and the ENTITY has accepted the Bid by the SUPPLIER for the supply of those goods and services in the sum of TWO MILLION NINE HUNDRED NINETY-FOUR THOUSAND THREE HUNDRED FORTY-SIX PESOS (PHP2,994,346.00), inclusive of all applicable taxes hereinafter called the "CONTRACT PRICE";

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - iii. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iv. Performance Security;
 - v. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - vi. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of TWO MILLION NINE HUNDRED NINETY-FOUR THOUSAND THREE HUNDRED FORTY-SIX PESOS (PHP2,994,346.00), inclusive of all applicable taxes, or such other sums as may be ascertained, the SUPPLIER agrees to deliver the PACKAGING AND INTERNATIONAL AND LOCAL DOOR TO DOOR COURIER AND MESSENGERIAL SERVICES OF BUCKET LIST COFFEE TABLE BOOK EDITION 3 in accordance with its Bid.
- 4. The ENTITY agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
