## RECOMMENDING AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT TO TANJER ENTERPRISES FOR THE SUPPLY AND DELIVERY OF TWO HUNDRED (200) SETS OF TPB GO BAG

**WHEREAS**, there is an approved Purchase Request (PR) No. 11.027 with an Approved Budget for the Contract (ABC) of **Five Hundred Thousand Pesos Only** (**PhP500,000.00**), for the Supply and Delivery of Two Hundred (200) sets of TPB Go Bag that contain first aid kit, led flashlight, multi-tool knife, antibacterial soap, N95 masks, paracord braided survival bracelet, water bottle, whistle, pulse oximeter for TPB personnel emergency use and subject to annual inspection;

**WHEREAS**, said item is included in the Annual Procurement Plan/Updated Project Procurement Management Plan of the TPB for 2021;

**WHEREAS**, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA 9184);

**WHEREAS,** in accordance with the provisions of Section 53.9 of the RIRR of RA 9184: the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex "H" of the RIRR, provided that in case of Goods, the Procurement does not fall under Shopping in Section 52 of the RIRR;

**WHEREAS,** the Bids and Awards Committee (BAC) Secretariat posted the Request for Quotation (TPB-PR 2021.12.441) dated December 2, 2021 on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on December 10, 2021;

**WHEREAS,** Tanjer Enterprises, DVK Philippines Enterprises, Merit Stainless Steel Inc., and Avecilla Trading submitted their bid quotations before the set deadline of submission;

**WHEREAS,** the Technical Evaluators for Alternative Methods of Procurement opened the submitted quotations on December 10, 2021, *with the following details*:
