**RECOMMENDING AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT
TO INTAS DESTINATION MANAGEMENT, INC. FOR THE SERVICES OF A TOUR
OPERATOR FOR PHILIPPINE MOTORCYCLE TOURISM NCR & ENVIRONS DAY-RIDE**

WHEREAS, there is an approved Purchase Request (PR) No. 12.038 with an Approved Budget for the Contract (ABC) of **One Million Pesos (PhP1,000,000.00)**, for the **Services of a Tour Operator for Philippine Motorcycle Tourism NCR & Environs Day-Ride**;

WHEREAS, said item is included in the Annual Procurement Plan/Updated Project Procurement Management Plan of the TPB for 2021;

WHEREAS, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA 9184);

WHEREAS, in accordance with the provisions of Section 53.9 of the RIRR of RA 9184, the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex “H” of the RIRR, provided that in case of Goods, the procurement does not fall under Shopping in Section 52 of the RIRR;

WHEREAS, the Bids and Awards Committee (BAC) - Secretariat, posted the Request for Quotation (TPB-PR 2021.12.469) dated December 22, 2021 on the PhilGEPs and TPB Websites with a *deadline* of submission of bids on December 27, 2021;

WHEREAS, Intas Destination Management, Inc., Anset Holidays, Inc., and Creative Travel & Tours International submitted their bid proposal before the set deadline of submission;

WHEREAS, the Technical Evaluators for Alternative Methods of Procurement opened the submitted quotations on December 27, 2021, *with the following details*:


