**RECOMMENDING AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT  
TO JONECO TECH MARKETING CORP. FOR THE PROCUREMENT OF FIVE (5) UNITS  
MULTI-FUNCTION PRINTER**

**WHEREAS**, there is an approved Purchase Request (PR) No. 12.009 with an Approved Budget for the Contract (ABC) of **Two Hundred Twenty-Five Thousand Pesos Only (Php225,000.00)**, for procurement of 5 units of Multi-function Printer for Corporate Planning & Business Development Department, Domestic Promotions Department, International Promotions Department, Management Information Systems Department, and the Office of the Corporate Board Secretary;

**WHEREAS**, said item is included in the Annual Procurement Plan/Updated Project Procurement Management Plan of the TPB for 2021;

**WHEREAS**, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA 9184);

**WHEREAS**, in accordance with the provisions of Section 53.9 of the RIRR of RA 9184: *the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex "H" of the RIRR, provided that in case of Goods, the Procurement does not fall under Shopping in Section 52 of the RIRR;*

**WHEREAS**, the Bids and Awards Committee (BAC) Secretariat posted the Request for Quotation (TPB-PR 2021.12.448) dated December 3, 2021 on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on December 10, 2021;

**WHEREAS**, on December 9, 2021 PrintCore Office Systems, Inc. submitted its bid quotation;

**WHEREAS**, on December 10, 2021 JONECO Tech Marketing Corp. submitted its bid quotation;

**WHEREAS**, on December 10, 2021 EPartners Solutions, Inc. submitted its bid quotation;

**WHEREAS**, the Technical Evaluators for Alternative Methods of Procurement opened the submitted quotations on December 10, 2021, *with the following details:*
