RESOLUTION NO. 2022-009**

**RECOMMENDING AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT
TO POWER HOUSE PEST CONTROL SERVICES FOR THE OFFICE DISINFECTION
SERVICES OF TPB PREMISES**

WHEREAS, there is an approved Purchase Request (PR) No. 1.011 with an Approved Budget for the Contract (ABC) of **Three Hundred Thousand Pesos Only (Php300,000.00)**, for the Office Disinfection Services of TPB Premises from January 2022 to December 2022;

WHEREAS, said item is included in the Annual Procurement Plan/Updated Project Procurement Management Plan of the TPB for 2022;

WHEREAS, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA 9184);

WHEREAS, in accordance with the provisions of Section 53.9 of the RIRR of RA 9184: *the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex "H" of the RIRR, provided that in case of Goods, the Procurement does not fall under Shopping in Section 52 of the RIRR;*

WHEREAS, the Bids and Awards Committee (BAC) Secretariat posted the Request for Quotation (TPB-PR 2022.01.009) dated January 5, 2022 on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on January 12, 2022;

WHEREAS, the following supplies submitted bid quotations before the deadline:

1. January 7, 2022 - Power House Pest Control Services;
2. January 8, 2022 Philippine Vision Group, Inc.; and
3. January 11, 2022 Mac J Pest Control Services

WHEREAS, the Technical Evaluators for Alternative Methods of Procurement opened the submitted quotations on January 12, 2022, *with the following details:*
