**RECOMMENDING AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT
TO IVALUE TECHNOLOGIES CORPORATION FOR THE SERVICE MAINTENANCE OF
TPB'S PABX SYSTEM**

WHEREAS, there is an approved Purchase Request (PR) No. 1.015 with an Approved Budget for the Contract (ABC) of **Eighty-Eight Thousand Pesos Only (PhP88,000.00)**, for the Quarterly Service Maintenance of TPB's **Private Automated Branch Exchange (PABX)** Telephone Network System for NEC SL 2100 for the year 2022;

WHEREAS, said item is included in the Annual Procurement Plan/Updated Project Procurement Management Plan of the TPB for 2022;

WHEREAS, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA 9184);

WHEREAS, in accordance with the provisions of Section 53.9 of the RIRR of RA 9184: *the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex "H" of the RIRR, provided that in case of Goods, the Procurement does not fall under Shopping in Section 52 of the RIRR;*

WHEREAS, the Bids and Awards Committee (BAC) Secretariat posted the Request for Quotation (TPB-PR_2022.01.010) dated January 6, 2022 on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on January 14, 2022;

WHEREAS, on January 14, 2022, IValue Technologies Corporation submitted its bid quotation;

WHEREAS, the Technical Evaluators for Alternative Methods of Procurement opened the submitted quotation on January 14, 2022, *with the following details:*
