**RECOMMENDING AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT
TO JUAN PASYALAN TRAVEL AND TOURS FOR THE SERVICES OF A TOUR OPERATOR
FOR THE REGIONAL TRAVEL FAIR 2022 SITE VALIDATION TRIP IN BICOL AND LAGUNA**

WHEREAS, there is an approved Purchase Request (PR) No. 1.029 with an Approved Budget for the Contract (ABC) of **One Hundred Seventy-Five Thousand Five Hundred Pesos (Php175,500,000.00)**, for the services of a tour operator for site validation trip to Sorsogon, Bicol on February 7-9, 2022 and Sta. Rosa, Laguna on March 3-5, 2021;

WHEREAS, said item is included in the Annual Procurement Plan/Updated Project Procurement Management Plan of the TPB for 2022;

WHEREAS, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA 9184);

WHEREAS, in accordance with the provisions of Section 53.9 of the RIRR of RA 9184: *the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex "H" of the RIRR, provided that in case of Goods, the Procurement does not fall under Shopping in Section 52 of the RIRR;*

WHEREAS, the Bids and Awards Committee (BAC) Secretariat posted the Request for Quotation (TPB-PR_2022.01.017) dated January 19, 2022 on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on January 26, 2022;

WHEREAS, on January 24, 2022, Annset Holidays, Inc. submitted its bid quotation;

WHEREAS, on January 26, 2022, Travel Expert, Inc. submitted its bid quotation;

WHEREAS, on January 26, 2022, Juan Pasyalan Travel and Tours submitted its bid quotation;

WHEREAS, the Technical Evaluators for Alternative Methods of Procurement opened the submitted quotation on January 26, 2022, *with the following details*:
