**RECOMMENDING AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT  
TO NICATTO EVENTS AND MARKETING DYNAMICS CORPORATION THE SUPPLY AND  
DELIVERY OF BIRTHDAY CAKES TO TOURISM PROMOTIONS BOARD'S EMPLOYEES**

**WHEREAS**, there is an approved Purchase Request (PR) No. 2.009 with an Approved Budget for the Contract (ABC) of **Two Hundred One Thousand Six Hundred Pesos (Php201,600.00)**, for the supply and delivery of Birth Day Cake to Tourism Promotions Board (TPB) employees in various destination;

**WHEREAS**, said item is included in the Annual Procurement Plan/Updated Project Procurement Management Plan of the TPB for 2022;

**WHEREAS**, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA 9184);

**WHEREAS**, Section 53.9 of the RIRR of RA 9184 provides that *"the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex "H" of the RIRR, provided that in case of Goods, the Procurement does not fall under Shopping in Section 52 of the RIRR"*;

**WHEREAS**, the Bids and Awards Committee (BAC) Secretariat posted the Request for Quotation (TPB-PR\_2022.02.029) dated February 8, 2022 on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on February 14, 2022;

**WHEREAS**, on February 14, 2022, ESMC General Merchandising and Consumer Goods Trading and NICATTO Events and Marketing Dynamics Corporation submitted their bid quotation;

**WHEREAS**, the Technical Evaluators for Alternative Methods of Procurement opened the submitted quotation on February 14, 2022, *with the following details*:






