**RECOMMENDING AWARD OF CONTRACT THROUGH DIRECT CONTRACTING
PROCUREMENT TO GAKKEN PHILIPPINES INC. FOR THE SUPPLY AND DELIVERY OF
DUPLO BLACK INK AND MASTER ROLL**

WHEREAS, there is an approved Purchase Request (PR) No. 2.029 with an Approved Budget for the Contract (ABC) of **Eight Thousand One Hundred Ninety-Three Pesos (PhP8,193.00)**, for the supply and delivery Duplo black ink and master roll;

WHEREAS, said item is included in the Annual Procurement Plan/Updated Project Procurement Management Plan of the TPB for 2022;

WHEREAS, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA 9184);

WHEREAS, Section 50 (c) of the RIRR of RA 9184 provides that *“the procuring entity may resort to direct contracting when goods are sold by an exclusive dealer or manufacturer which does not have sub-dealer selling at the lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GOP”*;

WHEREAS, Gakken Philippines, Inc., is appointed as the exclusive sales distributor for all Duplo Products in the Philippines for the year 2022. Gakken Philippines Inc., is also authorized to sell relevant Duplo branded consumables, spare parts, and maintenance services in line with the above said product;

WHEREAS, the Bids and Awards Committee (BAC) Secretariat sent the Request for Quotation (TPB-PR_2022.02.044) dated February 23, 2022 to a capable supplier and set the *deadline* of submission of bids on March 4, 2022;




