## RECOMMENDING AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT TO PHILCOPY CORPORATION FOR THE SUPPLY AND DELIVERY MID-SIZE HEAVY DUTY **DOCUMENT SHREDDER**

WHEREAS, there is an approved Purchase Request (PR) No. 2.039 with an Approved Budget for the Contract (ABC) of Fifty-one Thousand Pesos (PhP51,000.00), for the supply and delivery of one (1) unit Mid-size Heavy Duty Document Shredder;

WHEREAS, said item is included in the Annual Procurement Plan/Updated Project Procurement Management Plan of the TPB for 2022;

WHEREAS, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA 9184);

WHEREAS, Section 53.9 of the RIRR of RA 9184 provides that "the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex "H" of the RIRR, provided that in case of Goods, the Procurement does not fall under Shopping in Section 52 of the RIRR";

WHEREAS, the Bids and Awards Committee (BAC) Secretariat posted the Request for Quotation (TPB-PR\_2022.02.050) dated February 28, 2022 on the PhilGEPS and TPB Websites with a deadline of submission of bids on March 7, 2022;

WHEREAS, on March 2, 2022, Business Machine Corporation submitted their bid quotation;

WHEREAS, on March 7, 2022, Philcopy Corporation submitted their quotation;

WHEREAS, the Technical Evaluators for Alternative Methods of Procurement opened
