**RECOMMENDING AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT
TO JUAN PASYALAN TRAVEL AND TOURS FOR THE SERVICES OF TOUR OPERATOR FOR
AIR ASIA MAIDEN FLIGHT**

WHEREAS, there is an approved Purchase Request (PR) No. 3.050 with an Approved Budget for the Contract (ABC) of **Ninety-five Thousand Pesos (Php95,000.00)**, for the Services of Tour Operator for Air Asia Maiden Flight;

WHEREAS, said item is included in the approved Project Procurement Management Plan of the Department and the indicated Annual Procurement Plan of the Tourism Promotions Board for Fiscal Year 2022;

WHEREAS, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA 9184);

WHEREAS, Section 53.9 of the RIRR of RA 9184 provides that *“the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex “H” of the RIRR, provided that in case of Goods, the Procurement does not fall under Shopping in Section 52 of the RIRR”*;

WHEREAS, the Bids and Awards Committee (BAC) Secretariat posted the Request for Quotation (TPB-PR_2022.03.093) dated March 24, 2022 on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on March 28, 2022;

WHEREAS, on March 26, 2022, Juan Pasyalan Travel and Tour submitted their bid quotation;

WHEREAS, on March 28, 2022, Shroff International Travel Care, Inc. submitted their bid quotation;

WHEREAS, the Technical Evaluator for Alternative Methods of Procurement opened the submitted quotation on March 28, 2022, *with the following details*:






