**WHEREAS**, there is an approved Purchase Request (PR) No. 3.031 with an Approved Budget for the Contract (ABC) of **One Hundred Thirty-five Thousand Pesos (Php135,000.00)**, for the Services of Tour Operator for Inspection Trip to Corregidor Island;

**WHEREAS**, said item is included in the Annual Procurement Plan/Updated Project Procurement Management Plan of the TPB for 2022;

**WHEREAS**, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA 9184);

**WHEREAS**, Section 53.9 of the RIRR of RA 9184 provides that *“the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex “H” of the RIRR, provided that in case of Goods, the Procurement does not fall under Shopping in Section 52 of the RIRR”*;

**WHEREAS**, the Bids and Awards Committee (BAC) Secretariat posted the Request for Quotation (TPB-PR\_2022.03.079) dated March 14, 2022 on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on March 18, 2022;

**WHEREAS**, on March 16, 2022, Juan Pasyalan Travel and Tour submitted their bid quotation;

**WHEREAS**, on March 18, 2022, Amazing Trails Travel Co. Ltd. and Shroff International Travel Care, Inc. submitted their bid quotations;

**WHEREAS**, the Technical Evaluators for Alternative Methods of Procurement opened the submitted quotation on March 18, 2022, *with the following details*:
