**RECOMMENDING AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT
TO RBHC COURIER SERVICE FOR THE SHIPMENT OF PROMOTIONAL MATERIALS AND
GIVEAWAYS TO THE PHILIPPINE DEPARTMENT OF TOURISM TOKYO, JAPAN OFFICE
FOR MARINE DIVING FAIR 2022**

WHEREAS, there is an approved Purchase Request No. 3.002 with an Approved Budget for the Contract (ABC) of **Seventy-Five Thousand Pesos (PhP75,000.00)** for the Shipment of promotional materials and giveaways to the Philippine Department of Tourism Tokyo, Japan Office relative to Marine Diving Fair 2022;

WHEREAS, said item is included in the approved Project Procurement Management Plan of the Department and the indicative Annual Procurement Plan of the Tourism Promotions Board for Fiscal Year 2022;

WHEREAS, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act (R.A.) No. 9184;

WHEREAS, Section 53.9 of the RIRR of R.A. No. 9184 provides that *"the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex "H" of the RIRR, provided that in case of Goods, the Procurement does not fall under Shopping in Section 52 of the RIRR"*;

WHEREAS, the Bids and Awards Committee (BAC) Secretariat posted the Request for Quotation (TPB-PR_2022.03.080) dated March 14, 2022 on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on March 18, 2022;

WHEREAS, on March 18, 2022, RBHC Courier Service submitted their bid quotation. The Technical Evaluators for Alternative Methods of Procurement opened the submitted quotation on March 18, 2022, *with the following details*:


