**RECOMMENDING AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT
TO RBHC COURIER SERVICE FOR THE DOOR TO DOOR AIR SHIPMENT OF
PROMOTIONAL MATERIALS AND GIVEAWAYS TO THE PHILIPPINE DEPARTMENT OF
TOURISM USA OFFICES**

WHEREAS, there is an approved Purchase Request (PR) No. 3.001 with an Approved Budget for the Contract (ABC) of **Four Hundred Fifty Thousand Pesos (Php450,000.00)**, for the Door to door Air Shipment of Promotional Materials and Giveaways to the Philippine Department of Tourism USA offices;

WHEREAS, said item is included in the Annual Procurement Plan/Updated Project Procurement Management Plan of the TPB for 2022;

WHEREAS, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA 9184);

WHEREAS, Section 53.9 of the RIRR of RA 9184 provides that *“the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex “H” of the RIRR, provided that in case of Goods, the Procurement does not fall under Shopping in Section 52 of the RIRR”*;

WHEREAS, the Bids and Awards Committee (BAC) Secretariat posted the Request for Quotation (TPB-PR_2022.03.057) dated March 4, 2022 on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on March 10, 2022;

WHEREAS, on March 7, 2022, EMR Courier Services International Inc. submitted their bid quotation;

WHEREAS, on March 10, 2022, RBHC Courier Service submitted their bid quotation;

WHEREAS, the Technical Evaluators for Alternative Methods of Procurement opened the submitted quotation on March 10, 2022, *with the following details*:


