I. BACKGROUND

AirAsia's flights connecting Manila to Dumaguete will commence operations on 08 April 2022 after closing operation for two years because of the COVID-19 Pandemic. Known movers of the tourism industry including some officials of DOT and TPB have been invited to join the maiden flight to Dumaguete on 08 April 2022.

The Tourism Promotions Board (TPB) Philippines Chief Operating Officer was invited to deliver Keynote Message during the following events:

- Launching of Canlaon, Siyudad Ko, Suroyon ko a local initiative to bounce back the city's tourism industry with various tourism related activities wherein Canlaon City will present its calendar of activities with its tourism partners, stakeholders and collaborators
- 2. Saka sa Hinakpan Opening Ceremony a tourism recovery program of the City Government of Guihulngan wherein there is hiking and overnight stay at the foot of the famous Hinakpan Hills

TPB requires the services of a tour operator service provider for the logistical requirements of the TPB personnel. Prospective bidders may offer to bid given that the proposal does not exceed the provided Approved Budget for the Contract (ABC).

III. ADDITIONAL TECHNICAL ELIGIBILITY REQUIREMENTS

- Must be legally registered tour operator or travel agency under Philippine laws for 3 years.
 Required to submit proof of registration either from SEC, DTI or CDA;
- Must have previously completed a minimum of 3 projects for the past 3 years' in providing/ servicing tour operations for National Government Agencies (NGAs), Local Government Units (LGUs) and/or Private Agencies, Institutions or Organizations.
- Must be DOT-accredited tourism establishment. Required to submit either a DOT accreditation certificate or provisional accreditation certificate;
- Must have rebooking, transferable or refundable policies.

IV. APPROVED BUDGET FOR THE CONTRACT (ABC)

The ABC is Ninety-FiveThousand Pesos Only (₱95,000.00) inclusive of applicable taxes and fees.
