## DECLARING AS THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF THE CONTRACT TO JONECO TECH MARKETING CORP. FOR LOT 1 AND LOT 2 FOR THE SUPPLY AND DELIVERY OF LAPTOP AND TABLET COMPUTER

WHEREAS, there is an approved Purchase Request (PR) Nos. 3.059 & 3.060 with a total approved Budget for the Contract (ABC) of Six Million Pesos (Php6,000,000.00), for three (3) Lots project Supply and delivery of Laptop and Tablet Computer.

WHEREAS, said item is included in the approved Project Procurement Management Plan of the Department and the Annual/Supplemental Procurement Plan of the Tourism Promotions Board for Fiscal Year 2022;

WHEREAS, the TPB, through its Bids and Awards Committee (BAC), posted the Invitation to Bid No. TPB-ITB No. 2022-005 Supply and delivery of Laptop and Tablet Computers for three (3) Lots with a total Approved Budget for the Contract (ABC) of Six Million Pesos (Php6,000,000.00), in the TPB website (www.tpb.gov.ph), the PhilGEPS and conspicuous place at the premises of TPB for twenty-one (21) days;

**WHEREAS**, on April 20, 2022, the Bids and Awards Committee (BAC) held the pre-bid conference, which was attended by the following prospective bidders:

**WHEREAS**, for purposes of clarifying the technical specifications and requirements, the BAC, through its BAC Secretariat issued Supplemental Bid Bulletin No. 2022-010 dated April 20, 2022, and Supplemental Bid Bulletin No 2022-011 dated April 22, 2022;

**WHEREAS**, on May 2, 2022, Quartz Business Products Corp. submitted its bid proposals for Lot 2 and Lot 3, within the prescribed deadline of submission of bids;

**WHEREAS,** on May 4, 2022, Masangkay Computer Center submitted its bid proposal for Lot 1, within the prescribed deadline of submission of bids;

**WHEREAS**, on May 4, 2022, Joneco Tech Marketing Corp. submitted its bids proposal for Lot 1 and Lot 2, within the prescribed deadline of submission of bids;

**WHEREAS,** on May 4, 2022, during the opening of the bids, the BAC, Project Officer, and the BAC Technical Working Group (TWG) examined the bid proposal submitted by the bidders for Lot 1-3 using the non-discretionary "pass/fail" criterion;

WHEREAS, for Lot 1, the BAC Members declared the bid of Masangkay Computer Center, Joneco Tech Marketing Corp., as Compliant and Eligible, subject to bid evaluation;

WHEREAS, for Lot 2, the BAC Members declared the bid of Joneco Tech Marketing Corp., as Compliant and Eligible, subject to bid evaluation, while Quartz Business Product Corp., was declared Non-Compliant and Ineligible;

WHEREAS, for Lot 3 the BAC Members declared the bid of Quartz Business Product Corp., as Compliant and Eligible, subject to bid evaluation;

**WHEREAS**, the BAC proceeded to open the financial proposal submitted by the bidders, and the result as read are as follows:

NOW THEREFORE, for and in consideration of the foregoing, we, the member of the Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED to recommend the following:

- a) to DECLARE Joneco Tech Marketing Corp., bids for Lot 1 and Lot 2 for the Supply and Delivery of Laptop and Tablet Computer as the Single Calculated Responsive Bid (SCRB);
- b) to **DECLARE FAILURE OF BIDDING** for Lot 3, Supply and Delivery of 11 units of Tablet Computer;
- c) to **CONDUCT** the **RE-BIDDING** for Lot 3, Supply and Delivery of 11 units of Tablet Computer in accordance with the pertinent procurement rules and regulations under the R.A. 9184 and its RIRR and related GPPB issuances:
- c) to RECOMMEND for approval of the TPB Chief Operating Officer the AWARD of Contract to Joneco Tech Marketing Corp., for Supply and Delivery of Laptop Computers for Lot 1 and Lot 2 in the amount of Four Million Three Hundred Ninety-two Thousand Four Hundred Eighty-six Pesos (Php 4,392,486.00) for Lot 1, inclusive of all applicable taxes and One Million Five Thousand Five Hundred Sixty-four Pesos (Php1,005,564.00) for Lot 2, inclusive of applicable taxes.
