KNOW ALL MEN BY THESE PRESENTS:

This Agreement made and entered into the City of Manila, Philippines this ____ day of _____ 2022 between the:

TOURISM PROMOTIONS BOARD, a government owned and controlled corporation, with principal address at 4th Floor, Legaspi Towers 300, Roxas Boulevard, Manila, Philippines, herein represented by its Chief Operating Officer, **MARIA ANTHONETTE C. VELASCO-ALLONES**, hereinafter called the "ENTITY" of the one part;

JONECO TECH MARKETING CORP., a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with business address at No. 7 Pioneer St., cor. Sheridan St., Elena Rocas Compound Highway Hills Mandaluyong City, herein represented by its Authorized and Designated Representative, **LAURENCE CHRISTOPHER S. TAGLE**, hereinafter called the "SUPPLIER" of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the "SUPPLY AND DELIVERY OF LAPTOP AND TABLET COMPUTERS" in the sum of **FOUR MILLION THREE HUNDRED NINETY-TWO THOUSAND FOUR HUNDRED EIGHTY-SIX PESOS ONLY (PhP4,392,486.00)** for Lot 1 (Supply and Delivery of 63 Units of Laptop), and **ONE MILLION FIVE THOUSAND FIVE HUNDRED SIXTY-FOUR PESOS (PhP1,005,564.00)** for Lot 2 (Supply and Delivery of 12 Units of Laptop for MANCOM Members), inclusive of all applicable taxes, hereinafter called the "Contract Price";

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - iii. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iv. Performance Security;
 - v. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - vi. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, shall likewise form part of the Contract.
3. In consideration for the sum of **FOUR MILLION THREE HUNDRED NINETY-TWO THOUSAND FOUR HUNDRED EIGHTY-SIX PESOS ONLY (PhP4,392,486.00)** for Lot 1 (Supply and Delivery of 63 Units of Laptop), and **ONE MILLION FIVE THOUSAND FIVE**
