**RECOMMENDING AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT  
TO MITNSIDE ENTERPRISES FOR SUPPLY, PRINTING, AND DELIVERY OF BUSINESS CARD**

**WHEREAS**, there is an approved Purchase Request (PR) No. 5.005 with an Approved Budget for the Contract (ABC) of **Four Thousand Seven Hundred Fifty Pesos (PhP4,750.00)**, for Supply, Printing, and Delivery of Business Card;

**WHEREAS**, said item is included in the approved Project Procurement Management Plan of the Department and the Annual/Supplemental Procurement Plan of the Tourism Promotions Board for Fiscal Year 2022;

**WHEREAS**, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA 9184);

**WHEREAS**, Section 53.9 of the RIRR of RA 9184 provides that *"the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex "H" of the RIRR, provided that in case of Goods, the Procurement does not fall under Shopping in Section 52 of the RIRR"*;

**WHEREAS**, the Bids and Awards Committee (BAC) Secretariat posted the Request for Quotation (TPB-PR\_2022.05.157) dated May 16, 2022 on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on May 20, 2022;

**WHEREAS**, on May 17, 2022, Mitnside Enterprises, submitted their bid quotation;

**WHEREAS**, the Technical Evaluator for Alternative Methods of Procurement opened the submitted quotation on May 20, 2022, *with the following details*:


