



## BIDS AND AWARDS COMMITTEE RESOLUTION NO. 2022-133

## RECOMMENDING AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT TO MITNSIDE ENTERPRISES FOR PRINTING OF TOURISM PROMOTIONS BOARD 2021 ANNUAL REPORT

WHEREAS, there is an approved Purchase Request (PR) No. 4.036 with an Approved Budget for the Contract (ABC) of **One Hundred Fifty Thousand Pesos** (PhP150,000.00), for Printing of Tourism Promotions Board (TPB) 2021 Annual Report;

WHEREAS, said item is included in the approved Project Procurement Management Plan of the Department and the Annual/Supplemental Procurement Plan of the Tourism Promotions Board for Fiscal Year 2022;

WHEREAS, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA 9184);

**WHEREAS,** Section 53.9 of the RIRR of RA 9184 provides that "the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex "H" of the RIRR, provided that in case of Goods, the Procurement does not fall under Shopping in Section 52 of the RIRR";

**WHEREAS,** the Bids and Awards Committee (BAC) Secretariat posted the Request for Quotation (TPB-PR\_2022.05.146) dated May 6, 2022 on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on May 12, 2022 12:00 Noon;

WHEREAS, on May 11, 2022, VJ Graphic Arts, Inc., PRP Printing Press, GA Printing, Inc., and Renalma Corp., submitted their bid quotation;

WHEREAS, on May 12, 2022, Zurbano Publishing & Printing Corp., Mitnside Enterprises, and Gilcor Printing Press submitted their bid quotation;



WHEREAS, on May 13, 2022, King Phil Printing Services, submitted its bid quotation beyond the delivery timeline;

**WHEREAS**, the Technical Evaluator for Alternative Methods of Procurement opened the submitted quotation on May 12, 2022, *with the following details*:
