



## BIDS AND AWARDS COMMITTEE RESOLUTION NO. 2022-184

DECLARING JUAN PASYALAN TRAVEL AND TOURS AS A LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT FOR THE SERVICES OF TOUR OPERATOR FOR INFLUENCER INVITATIONAL TOUR IN MANILA AND BORACAY

WHEREAS, there is an approved Purchase Request (PR) No. 6.006 with an Approved Budget for the Contract (ABC) of Nine Hundred Ninety-Nine Thousand Nine Hundred Ninety-Nine Pesos and 99/100 (PhP999,999.99), for the Services of Tour Operator for Influencer Invitational Tour in Manila and Boracay;

WHEREAS, said item is included in the approved Project Procurement Management Plan of the Department and the Annual/Supplemental Procurement Plan of the Tourism Promotions Board for Fiscal Year 2022;

WHEREAS, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA9184);

WHEREAS, Section 53.9 of the RIRR of RA 9184 provides that "the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex "H" of the RIRR, provided that in case of Goods, the Procurement does not fall under Shopping in Section 52 of the RIRR";

WHEREAS, the Bids and Awards Committee (BAC) Secretariat posted the Request for Quotation (TPB-PR\_2022.06.214) dated June 28, 2022 on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on July 8, 2022 12:00 Noon;

WHEREAS, on July 8, 2022, Juan Pasyalan Travel and Tours, and Intas Destination Management Inc. submitted their bid quotations before the set deadline of submission;

**WHEREAS**, the Technical Evaluators for Alternative Methods of Procurement opened the submitted quotation on July 8, 2022, with the following details:
