DECLARING DONSOL ECO TOUR INC. AS A LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) FOR LOT 1, JUAN PASYALAN TRAVEL AND TOURS AS A SINGLE CALCULATED RESPONSIVE QUOTATION (SCRQ) FOR LOT 2-4 AND RECOMMENDING AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT FOR THE SERVICES OF TOUR OPERATOR FOR PHILIPPINE TOURISM INFLUENCER PROGRAM

WHEREAS, there is an approved Purchase Request (PR) No. 6.033 with an Approved Budget for the Contract (ABC) of Nine Hundred Eighty-three Thousand Five Hundred Pesos (PhP983,500.00), for the Services of Tour Operator for Philippine Tourism Influencers Program (PTIP);

WHEREAS, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA9184);



WHEREAS, Section 53.9 of the RIRR of RA 9184 provides that "the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex "H" of the RIRR, provided that in case of Goods, the Procurement does not fall under Shopping in Section 52 of the RIRR";

WHEREAS, the Bids and Awards Committee (BAC) Secretariat posted the Request for Quotation (TPB-PR_2022.06.204) dated June 21, 2022 on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on June 27, 2022 12:00 Noon;

WHEREAS, on June 27, 2022, Donsol Eco Tour, Inc., Juan Pasyalan Travel and Tours, Earth Explorers Travel and Tours and Batanes Wakay Travel and Tours Incorporated submitted their bid quotations before the set deadline of submission;
