**DECLARING AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND
RECOMMENDING THE AWARD OF THE CONTRACT TO THE TEN O FIVE
PRODUCTIONS INC. FOR THE SERVICES OF AN EVENT MANAGEMENT COMPANY FOR
TPB'S PARTICIPATION IN THE 1ST PH RIDE WITH PURPOSE: UNITED WE RIDE FOR
GREENER FUTURE**

WHEREAS, there is an approved Purchase Request (PR) No. 6.002 with an Approved Budget for the Contract (ABC) of **Seven Hundred Fifty Thousand Pesos (Php750,000.00)**, for the Services of an Event Management Corporation for TPB's participation in the 1st PH Ride with Purpose: United We Ride for Greener Future on June 25, 2022;

WHEREAS, said item is included in the approved Project Procurement Management Plan of the Department and the Annual/Supplemental Procurement Plan of the Tourism Promotions Board for Fiscal Year 2022;

WHEREAS, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA 9184);

WHEREAS, Section 53.9 of the RIRR of RA 9184 provides that *"the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex "H" of the RIRR, provided that in case of Goods, the Procurement does not fall under Shopping in Section 52 of the RIRR"*;

WHEREAS, the Bids and Awards Committee (BAC) Secretariat posted the Request for Quotation (TPB-PR_2022.06.178) dated June 2, 2022 on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on June 9, 2022;

WHEREAS, on June 8, 2022, Ten O Five Productions, Inc. submitted its bid quotation;

WHEREAS, on June 9, 2022, Bright Solutions Marketing Services, Inc. and Total Exhibit and Expo Solutions Inc. submitted their respective bid quotations;

WHEREAS, the Technical Evaluator for Alternative Methods of Procurement

opened the submitted quotation on June 9, 2022, with the following details:
